REGISTER DELEGATES BY SEPTEMBER 9. Please ensure your board's delegate is registered for this special meeting being convened by the IASB Board of Directors. IASB members will vote on a proposed bylaws amendment regarding IASB's national membership. The IASB Bylaws currently make membership in the National School Boards Association (NSBA) mandatory. After careful consideration and due diligence, the IASB Board of Directors has determined it cannot recommend NSBA membership for 2022–23. TOOL OF THE MONTH—FAQ: REDISTRICTING FOLLOWING THE CENSUS

NOW AVAILABLE. Every 10 years, the federal government conducts a census to account for population density changes across the country. Normally, a change in the method of election or number of school board members must be placed on the ballot and voted upon by the electors in each school district. However, every 10 years, as part of this decennial census process, school districts may make these changes through board action.
