### **Online Policy Subscription Service**

The IASB **Policy Reference Manual** contains more than 600 pages of downloadable sample board policies, administrative regulations and forms needed by school districts to comply with state and federal laws and to effectively operate a school district. In addition, this subscription includes quarterly and special release updates through our *Policy Primer* newsletter. This newsletter issues new policies and/or updates to existing sample policies including explanations of why the policies are needed or laws that have changed impacting policy.

### **Legal Service Fund**

The IASB Legal Service Fund was developed to assist school districts, AEAs and community colleges in legal cases that have statewide significance. Monies in the fund are protected in a separate account and invested to maximize school district dollars.

The Legal Service Fund Committee consists of nine voting school board members from participating schools. This committee decides whether financial assistance will be provided to a participant that applies for such assistance. # **AT THE BOARD TABLE** www.ia-sb.org/attheboardtable



*At the Board Table* is an opportunity to add a board development item to your agenda. Boards that take time to discuss how they will work together generally find their common work at the board table to be easier and more effective. Estimated time commitment varies between 15 and 45 minutes per discussion.

It's possible to consider this section as an individual board member, but it is much more effective if the entire board engages in the discussion. Working as a team is improved when boards come to a common understanding of ground rules and responsibilities.



#### **STANDARD 1: VISIONARY TEAM**

#### **Considering Board Priorities at the Board Table**

This discussion helps the board team clarify where they want to focus their time and energies as they consider the most important goals for the district's future.

#### Whose Job Is It? Part One

Using a scenario of a typical board member situation, determine "Whose Job Is It?" and what role the whole board would play in the situation.

#### Whose Job Is It? Part Two

Another discussion on "Whose Job Is It?" focusing on the board's role in school improvement by looking at specific tasks and considering areas of work to be done.

#### **Board and Superintendent Relations, Part One**

This scenario-based discussion will help your team reflect on essential elements for building a productive board/superintendent relationship.

#### **Board and Superintendent Relations, Part Two**

A continued discussion tool including true/false questions and quotes to consider for building a productive board/superintendent relationship.

#### Promises and Pitfalls of Superintendent Evaluation

The board can assess its readiness for effective superintendent evaluation and support for the superintendent's performance goals.

### **STANDARD 2: STUDENT LEARNING**

#### Coherence: The Right Drivers – What is the Work of the Board?

These *At the Board Table* discussion exercises are based on Michael Fullan and Joanne Quinn's book, *Coherence: The Right Drivers in Action for Schools, Districts, and Systems*. These digital modules feature audio narration and support thoughtful board discussion with little prep time.

#### • Part One: Focusing Direction

The first exercise in this four-part series introduces the Coherence Framework and encourages discussion on how the board can provide challenge and support for a system focused on a common purpose, ambitious goals and the change leadership it takes to achieve them.

• Part Two: Cultivating Collaborative Cultures This module provides a framework for the board's discussion on how board behaviors impact district culture and how the board can foster and support innovation.



#### • Part Three: Deepening Learning

Through essential questions and building common understanding, this discussion helps the board consider the moral imperative of ensuring that all children reach deeper levels of learning—and how the board can help make that happen.

#### • Part Four: Securing Accountability

This final exercise gives the board a chance to discuss responsibility and understand how accountability can foster excellence in education and the key roles the board can play to secure accountability for results.

#### **Graduating All Students Innovation Ready**

An article and discussion guide help the board contemplate the need to go beyond the "status quo" to ensure students are ready for a changing future.

#### Thoughts Posed by Sir Ken Robinson

Three discussion exercises spotlight the board's role in nurturing innovative and creative cultures focused on personalized learning for all students. Listen to Sir Ken Robinson's thoughts on school transformation and discuss essential questions related to your board's vital work.

# **STANDARD 3: DISTRICT CULTURE**

#### **Discussing School Staff Performance with the Public**

This module uses a scenario and discussion questions to help the board consider citizen complaints objectively, away from the pressures of the actual situation.

#### Promises and Pitfalls of Superintendent Evaluation

The board can assess its readiness for effective superintendent evaluation and support for the superintendent's performance goals.

#### What Can the Board Know?

Dealing with personnel issues can be difficult. This discussion tool will help you think through possible actions and consequences related to the board's role in human resources.

### **STANDARD 4: POLICY AND LEGAL**

#### **Considerations on the Open Meetings Law**

A three-part discussion on how the Open Meetings Law affects board procedures.

What is ethical behavior? This module includes scenarios for the board to discuss with accompanying considerations from IASB and an opportunity for boards to consider how their own Code of Ethics policies help them govern well.

#### **Simplifying School Finance**

# **Roles and Responsibilities/Board Job Descriptions**

In this custom session, an IASB facilitator helps the board/superintendent team identify and discuss the different roles and responsibilities of school board members and the superintendent. The IASB facilitator will provide information and research on effective practices to enhance the discussions. The board/superintendent team uses these insights to build a strong, shared understanding of how each governance team member contributes to the district through their appropriate role.

### **Introduction to Strategic Planning: Mission, Vision and Goals**

Is your district ready to begin the strategic planning process? This experience will support the board/ superintendent team as they initiate the first phase of the strategic planning process: revising or creating the district's mission and vision and identifying goal areas for the district to pursue over the next three to five years. Workshops are typically two hours each—choose between one, two or three separate sessions depending on district needs. Sessions can focus on the board/superintendent team only or can include administration, staff, parents and community members. Additional sessions on data analysis and action planning are also available and can be added to complete the strategic planning process. The cost is customized based on the number of sessions, participants and facilitators involved.

### **Team Vision and Goal Setting**

This board workshop is designed to bring the board team together to articulate a clear vision for the future of their district and determine central beliefs that influence the decision-making process for the district. The program can be extended to creating a mission statement and/or goals for the district. The facilitator will provide a framework that allows the board to develop its vision and goals in an atmosphere that allows free expression of opinions and ideas.

#### **School Boards and Student Achievement**

Board/superintendent teams looking to strengthen their focus on student learning at the board table would benefit from this workshop. Participants can select entry points such as, data study, student learning goals, or understanding and supporting key initiatives. An IASB facilitator will consult with your district's board leadership and superintendent to determine an effective starting place. These workshops are developed based on effective practices for board teams influenced by IASB's groundbreaking Lighthouse Research and other studies on school board leadership.

### Leadership for Student Learning Five-Part Workshop Series

This workshop series is an intensive five-session commitment for the whole governance team to strengthen their role for improved teaching and student learning. Research shows that school boards who are well-informed with a strong belief system can positively influence student learning in their districts. Studies by IASB and other organizations have identified important leadership and policy-level roles for the school board in improving student learning. IASB is partnering with local board/ superintendent teams to support their efforts in this work through this in-depth workshop series.

### **Defining the Well-Educated Student**

As the governance team, it's the board's duty to establish a vision of high expectations for every child. In this workshop, an IASB facilitator will help the board/superintendent team create a customized visionary statement designed to inspire and elevate learning, provide direction and support sound policy and decision making.

### **Board Self-Assessment**

Governance teams are most effective when they foster a positive culture focused on improving instruction and student learning. An IASB facilitator will provide three to four self-assessment options and help the board identify the tool that best matches current needs.

### **Superintendent Evaluation**

Is your team interested in enhancing the superintendent evaluation process?

In this customized board workshop, an IASB facilitator will lead your team's learning and discussion on key areas of superintendent evaluation including legal requirements, the state's standards for school leaders, tools/practical tips, and effective practices.

### **Coming Together: District Sharing**

This workshop is designed to assist boards whether they want to explore possibilities for sharing with nearby districts, or their district is already engaged in sharing with other districts. The focus is to identify common interests, goals, concerns and to develop specific techniques to help boards

communicate and work together. These sessions can also be designed for boards engaging in reorganization discussions.

### **Creating a Culture of Excellence and Innovation: The School Board's Role**

What is the board's role in working with and guiding district staff? How does the board's role compare to that of the superintendent? How can your board/superintendent team work from your respective roles to create a culture of excellence and innovation that focuses the school community on student learning?

### **Sound Policy Development Practices for School Boards**

Sound written board policy clarifies the goals and intent of the board. In this custom session, an IASB consultant works with the board/administrative team to understand the board's policymaking role, strengthen your policy development and maintenance practices, identify policies most relevant to your district's current goals and needs and ensure your policies align with state and federal laws.

### **District Finance Consultation**

An IASB staff member will facilitate a customized review of your district's financial condition, based on your own data and trends, and help the board/superintendent team consider appropriate oversight and decision points to address the district's financial condition. IASB staff will work with the board, either at a board meeting or a board work session, to understand your district's finances. Free for the first consultation. IASB can also provide a half-day session one-on-one with a district's new superintendent or school business official to support these key administrators in gaining knowledge of Iowa school funding laws, processes and the district's current financial condition.

### **Developing Your Boards' Advocacy Action Plan**

To have a say in the legislative process, your board needs voice. In this session, an IASB staff member will work with your board to develop an advocacy action plan customized to your school district. You'll focus on specific issues facing your district and construct an advocacy plan based on maximizing efforts that will have the greatest impact in persuading your elected officials. The workshop can take a broad view on advocacy, or dig deep on a specific advocacy practice, such as legislator relations, community engagement, social media communications and more.

### New Superintendent and Board Leadership—Establishing a Strong Foundation

Establishing a Strong Foundation: If your superintendent is new to your district, IASB can help your team establish the foundation for a strong working relationship. An IASB facilitator will work with your board and superintendent leadership to develop a customized workshop to help your team set the stage for a successful school year. Popular topics for this workshop include areas such as: board-superintendent communications, operating practices, roles and responsibilities, expectations, or goals.

#### **Individual Achievement Award**

Board members are eligible to receive an Individual Achievement Award certificate for earning a minimum of 100 credits in one year. 70 of those credits must be earned in the Formal Learning category.

#### **Team Achievement Award**

A Team Achievement Award plaque is presented to a whole board when a majority of its board members receive Individual Achievement Awards for the year, and the board has a policy that supports board development.

#### Award of Honor

An Award of Honor certificate is given to each superintendent, AEA administrator or community college president who earns a minimum of 100 credits as an individual and has at least two board members who have earned Individual Achievement Awards.
