SAVE REVENUE LOSS TOOL

NEW TOOL! Governor Reynolds has released her property tax proposal. The bill is a fairly comprehensive change to the system and includes provisions related to school districts, most notably the amount of SAVE dollars that will be diverted to property tax relief through the Property Tax Equity and Relief Fund (PTER). Her proposal intends to increase the amount of SAVE revenue going to PTER to 30% by 2030. For comparison, 7% of SAVE revenue currently goes into PTER.
