



## Mandatory and Annual Review Policy Listing

On the following pages is a list of mandatory policies as cited in IASB's *Policy Reference Manual* (PRM). Mandatory policies are those policies for which a law, court case, or administrative rule requires **school districts and Area Education Agencies** to have a policy on a particular topic. Not all policies in the PRM are mandatory. Boards are required to review each policy at least every five years.

For a few select policies, a particular law or rule requires the board to review the policy language annually. These policies are also cited below.

Note that for mandatory policies, if the policy also has accompanying exhibits and/or regulation(s), these are also considered mandatory because they are considered necessary parts of the policy.

References to "I.C." mean *Iowa Code*. References to "I.A.C." mean *Iowa Administrative Code*.
