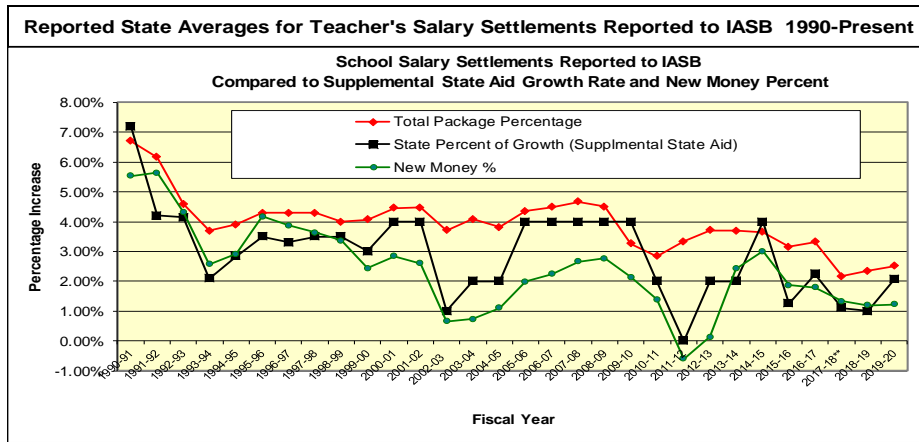




# School Settlement Data

The Iowa Association of School Boards (IASB) collects school settlement data each year. Information is voluntarily self-reported by school districts to IASB and the data is updated on the [IASB website](#) each week throughout the negotiation season.

The following chart and table provide statewide average school settlement information, new money amounts, the Supplemental State Aid (SSA) state percent of growth rate from 1990-91 through 2019-20, and the number of districts that self-reported their settlement data.

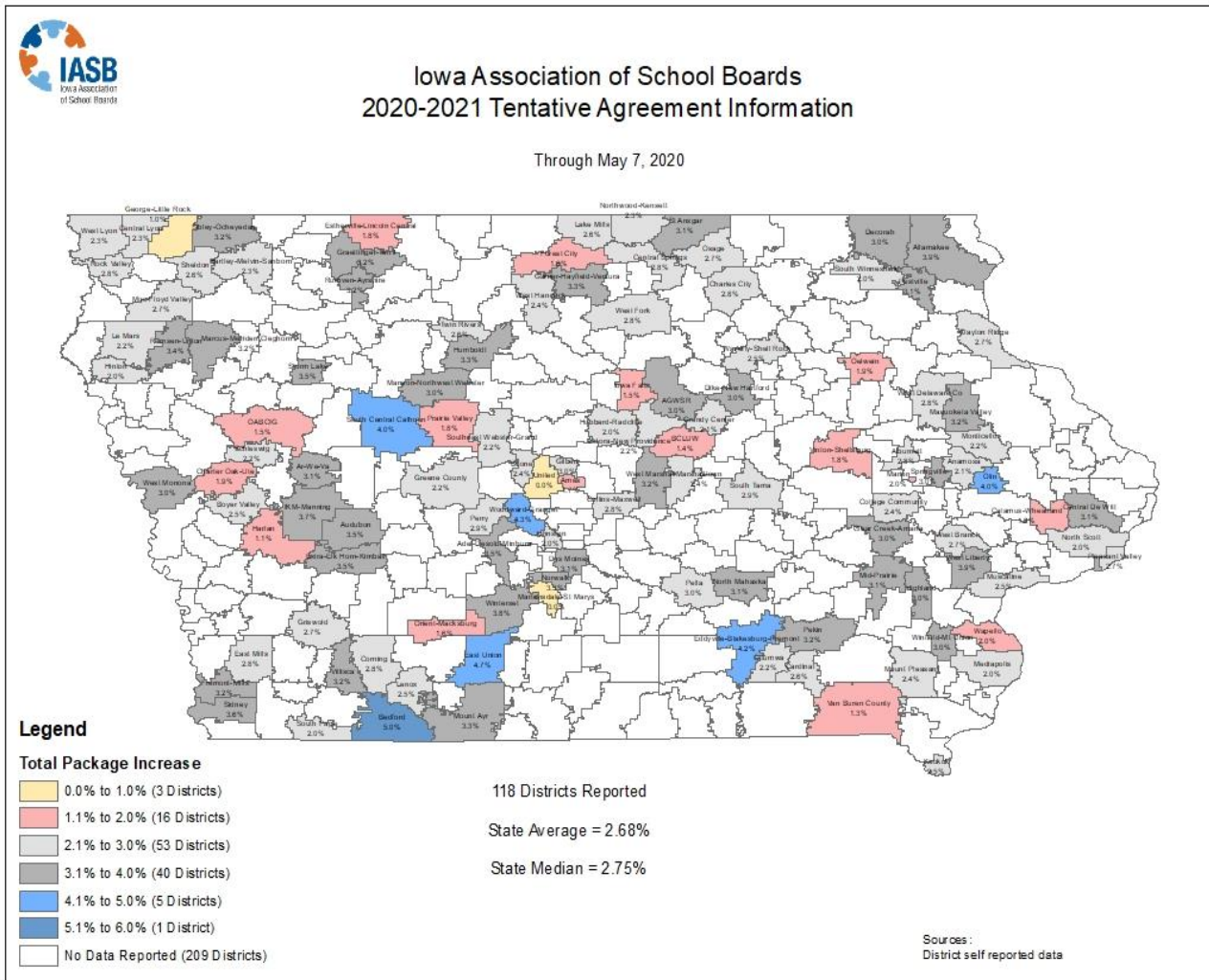

The following map provides 2020-21 school settlement as reported to IASB through May 7 (118 districts reporting). [See an updated list of districts that have reported.](#) Of note:

- The statewide average is currently 2.68%
- The state median is 2.75%
- For districts that settled prior to March 15, the average is 2.71% (32 districts)
- For the districts that settled after March 15, the average is currently 2.67%
